Description

Provide a short description of the event and its activities.

In this Webinar, which was the first event of our weUEsoUD project, we start to work on the objectives that we proposed in our application:

1- To raise awareness of the important role of women on various historical fronts and struggles: (a) Portuguese women, against the totalitarian regime of the Estado Novo in Portugal, before the revolution of 25 April 1974; b) To value the role of Lithuanian women against the authoritarian regime of the Soviet occupation; c) Recalling the important role of Greek women in the struggles for democracy, as well as in the fight against racism, xenophobia and the support of African

2 - To promote intersectoral cooperation, involving in the project municipal bodies, libraries, schools, universities, youth centres and NGOs.

3 - To establish a network between partners from different EU countries, trying to be as wide as possible, including participants from Southern Europe to Eastern Europe, to work together to spread the "Priorities of the European Commission".

We started the webinar with a welcome video from the Portuguese MEP Isabel Santos, followed by the presentation of the project and the themes to be addressed in situ by the project coordinator Mário Tavares (CARAVELA). This webinar was seen by the target group of thr project which were the project partners (17 partners from 16 European countries) as well as some public from third countries (Australia and Netherlands). In the last part of the event there were interventions from each of the partners about what they hoped to achieve with the weUEsoUd project for their institutions.

We think that we fully achieved what we proposed for this first event and that it was a good start for a project that we intend to be an example of success.
